- ✓ Submission deadline is 9:00 a.m., April 15, 2024.
- ✓ Write a two-page essay (type written using Times New Roman or Cambia font style and 12-point font size, double space) about the impact that community banking has had in your town and/or the state of Ohio. Do not use personal information in the essay.

## Eligibility Criteria

1. The scholarship is open to high school seniors that are children, stepchildren or foster children of Community Bank employees located in Ohio.
2. Ohio high school senior who is a current employee of an Ohio Community Bank.
3. Applicant must have a minimum GPA of 2.0 through the Junior Year of High School to be eligible for the scholarship.
4. Applicant must verify acceptance at an Ohio post-secondary institution with studies to begin in the summer or fall following high school graduation.
5. Applicant is required to write a two page essay (type written only) about the impact that community banking has had in their town and/or the state of Ohio – include both community and financial support your bank provides to others. **Please do not reference your town, bank name, or any other personal information in the essay.**
6. Applications for the scholarship must be received by April 15, 2024.
7. Scholarship awarded will be paid directly to the post-secondary institution designated by the applicant.
8. Applications received will be reviewed by a Select Committee consisting of no more than five (5) members.
9. Members of the Selection Committee are appointed by a Chairperson each year.
10. Contributions to the Ray Campbell Scholarship Fund are **NOT** tax deductible.
